NEW BUSINESS

Paul Crawford, City Building Inspector, reviewed items on a list that was presented to Council in regards to the inspection he did on a newly remodeled garage. Chief Boyer discussed the Dodge Charger with Council. The bank would pay \$8,300 for it and it could go for \$11K off a car lot. He asked Council if they wanted to take sealed bids.

Motion was made by Wade Schneider, seconded by Floyd Cozadd, to place sealed bid with reserve of \$6K for the Dodge Charger and selling it as is. Motion passed 5-0. Dana abstained.

The cutoff date for sealed bids will be February 12, 2015 at 5:00pm. Sealed bids to be turned into City Hall. At 12:00pm, the sealed bids will be opened.

Chief Boyer spoke with Council about the Head and Body Cameras from the Jefferson County Substance Abuse Council. He spoke with Lee about having a Policy in place for these. The video will be going to an external hard drive.
