NEW BUSINESS

Jim McGrath, Planning & Zoning Commissioner, updated Council regarding a letter sent May 21st, 2019 to Abeln & Associates to answer eight questions concerning Preliminary and Final Plat. Letter from them was received today July 9th, 2019 for Planning and Zoning meeting to be held Wednesday, July 17, 2019 at 6 p.m. to review Preliminary and Final Plat and responses to the eight questions. Carrie Daniels, City Clerk will email Heather with Abeln & Associates about final plat to be on Mylar paper to be submitted to Jefferson County Register of Deeds. Lee Hendricks, City Attorney relayed he did not feel a special meeting should be required by the council at this point. If Council Members are coming to Planning & Zoning Meeting they should let Carrie Daniels, City Clerk know ahead of time so she can post it on the door. Jim McGrath is waiting to hear from Mark Bachamp, City Engineer, as to whether he can be present at next Wednesday, July, 17th, 2019 meeting.

Janet Nitcher and her son were present to request that the City of Meriden amend their Vicious Dog Ordinance to a non-specific breed. Lee Hendricks, City Attorney explained several scenarios. Janet Nitcher's son relayed to council everyone owning pit bulls should have a \$1,000,000.00 insurance policy. They are approximately \$300 per year. If dog bite occurs, City process for dog bites is a 10-day quarantine at owner's expense which needs to be written in the agreement. Lee Hendricks, City Attorney, will bring Ordinance to next meeting taking out breed specific and including a million dollar Insurance Policy for council's review.

Mayor Boyer had to excuse herself for a moment. Discussion held on ditch line to the East of Richard Wadleigh's property. This property is in the County and Richard's property is in the City. After further discussion, this is the property owner's responsibility.

Motion made by Ken Parker, seconded by Richard White. Move to accept request to Consent Annexation of Barry White's property. BJ Whiteman, President of Council, asked all in favor, all said aye. Motion passed 4-0.
