NEW BUSINESS

She wants to rock or concrete dirt lot. Jackie Cummings is okay with it as long as her State Applications are approved.

Motion was made by Jackie Cummings, seconded by Ken Parker, that if Alicia submits her application to the State of Kansas for her Temporary Food Truck and upon approval from the State, council approves her Conditional Use Application as well. Motion passed 3-0.

Judge Dennis Reiling forwarded a proposal requesting council to approve a pay increase. He has not received a pay raise since 2001.

Motion made by Ken Parker, seconded by BJ Whiteman, to increase salary for Municipal Judge Dennis Reiling from \$250 to \$360 a month. Motion passed 3-0.

OLD BUSINESS

Discussion held on Kansas Turf (Mammoth, Inc.) Annexation and Proposal to drill and bore to the North would be about \$80,000. Issue was tabled until further notice.

Council is still waiting on a response from Kansas Department of Health and Environment (KDHE) regarding Countryside Square Sewer Lagoon. Issue tabled for now.

Sidewalk from East Main to K-4 Highway on South Miller Street, will have to wait for another time, as money is not in the budget.

REQUEST FOR SERVICE

BJ Whiteman requested the tree removal from creek West of Washington Street to help with water drainage. Matt Williams, Maintenance Department, met with Shane Old, property owner of the creek in being discussed. He was going to discuss this issue with his wife.

MAINTENANCE DEPARTMENT

King's Construction's bid was \$8,500 and the final bill came in at \$6,329, for rock/cement crushing at the snake pit concrete pile. King's Construction, Inc. also does concrete work. Bids were sent out to Schreiner Construction, King's Construction, Inc. and Bettis Asphalt.

Matt Williams advised that Andy Petesch said location of old water meter is unknown in Meriden City Park.

Motion was made by Ken Parker, seconded by Jackie Cummings, to discontinue use of the old water meter. Motion passed 3-0.

Wayne Ledbetter, County Commissioner relayed that Bill Noll, Jefferson County Road Department is putting a map together to present to Council Members to discuss who is responsible for maintaining which roads in the Meriden area and present to Council. Council will make a motion once map is presented.

Matt Williams relayed that the City of Meriden really needs an Emergency Management Plan. Jason Boyer, Chief of Police is working with Keith Jeffers, Emergency Management Planning in Oskaloosa to put together a plan.
