Jefferson West Ball Association will get drawing of bathrooms that are ADA compliant and talk with Barry White about tying sewer line in.

Jefferson West Ball Association would like to host the Meriden Festival. Alcohol is to be in limited locations as noted when submitting to ABC. Ken Parker asked what the lead time for notification for Meriden Festival and Lee Hendricks relayed 60-90 days.

Wade Schneider, Former Mayor is attending Fort Hayes State University under graduate classes. As a project, he was present to talk about Community 4 Community (C4C) Hunger Insecurity Project. Jefferson County has 2,100 people go hungry out of 18,000. Wade would like to put blessing boxes around Jefferson County and keep count on usage of the blessing boxes. # **OLD BUSINESS**

Kansas Department of Health and Environment (KDHE) has not answered regarding Countryside Square Sewer Lagoon. Lee Hendricks will send letter to KDHE reminding them of the request for Open Records.

#### POLICE DEPARTMENT TIME

Chief of Police, Jason Boyer handed out a list of Police calls during past month to Council Members for review.

Jason spoke about Blue Valley selling their tornado Sirens on 60 foot metal poles that have battery backup. Some are 3-years old and some are 10-years old. Chief Boyer said the bids came in at \$12,045 a piece, that includes delivery and installation. Discussion held on placement of sirens and will be determined later.

Motion was made by BJ Whiteman, seconded by Richard White, to purchase (2) two sirens and poles for \$24,090. Motion passed 4-0.

Chief Boyer thanked Matt Williams for installing the cameras in both Police Department vehicles which saved the city over \$500.

Tube off North Palmberg Street, will be ordered once Jefferson County relays install date.

King Construction will be getting with Matt Williams on rock crushing at lagoon. Matt relayed that he will be filling in areas with rock.
