OLD BUSINESS

Bob Hefner would like council to reconsider allowing people to ride their ATV's and register them with the City of Meriden.

Police Department paid for Snow Cones for Community and donated money to school from seized drug money from eight (8) years ago.

Jason Boyer, Chief of Police discussed excess hours. RE: Issue at Jefferson West High School and he would like to possibly go into executive session on this matter.

2019 Meriden Fall Festival Street Dance and Homecoming in the future month.

Richard White asked Jason Boyer about possible drug increase and whether Drug Dogs have been used in school. Jason Boyer relayed there is about the same amount of drugs in the school as there has been in the past.

BJ Whiteman asked when the last time a Drug Dog was taken to school for a search? Jason Boyer relayed a year and a half ago as dog retired. Jason Boyer relayed the first Vaping Death of Kansas was reported. He said there has been several children suspended due to catching them vaping in the restrooms. Further discussion was held on drug issues.

MAINTENANCE DEPARTMENT

Matt Williams, Maintenance Department, gave estimated cost on barriers for the Meriden Fall Festival to place on streets. Matt Williams has also located a generator.

Motion made by Ken Parker, seconded by Richard White, to buy or rent barriers in the amount of \$1,500 to be taken from General Fund. Motion passed 4-0.

MAINTENANCE DEPARTMENT – CON'T

Matt Williams informed council that the Masonic Temple was having a large meeting. They are needing to enter the building. To make this possible the City of Meriden is renting plates from R&S to make a path over construction for them to enter their building.

Motion made by Richard White, seconded by Jackie Cummings, to approve \$2,100 for the repair of Prairie Bend Estates concrete fraction. Motion passed 4-0.

Richard White relayed status of Sewer Pumps, Two (2) pumps were sent out, One (1) pump was needing to be replaced and other two (2) were sent out to be rebuilt. Cost on the replacement of one (1) pump is \$12,250 plus Labor with warranty through P1 Group. Pump can be bought for \$10,000 but would probably end up coming out anyway. Richard White knows this company, the approximate labor cost is \$1,300.

Motion made by Richard white, seconded by Ken Parker, to go forth with new pump for \$12,250 plus labor with P1 Group. Motion died for lack of vote after further discussion.

Motion made by Ken Parker, seconded by Richard White, to authorize up to \$25,000 for the purchase of one (1) pump and rebuilding or purchasing of another, to come from the Equipment Fund. Motion passed 4-0

ATTORNEY TIME

Lee Hendricks, City Attorney, presented the Memorandum of Understanding (MOU) and Jefferson County Approved Map to council along with map that was approved by Bill Noll, Jefferson County Public Works Director.

Motion made by Jackie Cummings, seconded by Richard White, to approve Memorandum of Understanding. Motion passed 4-0.

Lee Hendricks informed council about the Better for Nutrition Building that they were wanting to open it to be used for donation only. Lee will write a letter to Hal Smith, Owner, to inform him it would have to be used as a church or rezoned for a business at 101 W Wyandotte St.
