# CITY OF MERIDEN APPROVED MINUTES REGULAR CITY COUNCIL MEETING FEBRUARY 11, 2020

#### **NEW BUSINESS**

Kevin Gardner with Orion Waste Solutions was present to introduce himself and relayed council may call him should they have any issues. City of Meriden has a contract that renews this year.

Nick Rudy and Matt Armfield, Evergy Representatives, were present to explain to council of their plans to put up single poles and where the blanket easements they are requesting from City of Meriden, are located.

Temporary Easement is needed in yellow strip area and blanket easements converted in green area. \$4,000 per acre, Lagoon \$1,000 per acre yellow area, \$2,500 per acre green area, total \$7,072.00 total to City of Meriden Construction is two (2) years out.

Lee Hendricks, City Attorney, asked about City of Meriden accessibility to the Sewer Lagoons and Nick with Evergy, explained that they will not block access. Evergy Wires are 24 ½ feet above ground. This is one of the last 69 Volt Grids. Please contact Nick Rudy at Evergy if Council has no issues.

W-9 Form, Right of Way and Contract, Lee Hendricks, City Attorney will look and approve the documents before signing at the next meeting.

Don Welborn, Meriden Community Church off of Dawson and Palmer St. was present and would like to change a portion of the empty lot to a parking lot. They currently pay a vacant lot rate of \$22.97 got sewer rate.

Motion made by Megan Steele, seconded by Floyd Cozadd, to do away with Sewer Tap for Meriden Community Church and Vacant Lot Rate Fee and will now be used as a parking lot only. Motion passed 3-0.

Richard White asked that Matt Williams be allowed to dig around to make sure this is capped off correctly and Don Welborn stated he would approve the digging.

Engagement Letter is no cost and non-binding to the City of Meriden. It allows them to go forward and he will get engagement letter to be signed by Mayor Dana Boyer if approved.

Mayor Dana Boyer relayed for him to send Engagement Letter to Carrie Daniels, City Clerk, and she would get ahold of Mayor to sign. Council was okay with her signing as well.

### POLICE DEPARTMENT TIME

Jason Boyer, Chief of Police spoke of all the different school functions going on.

Substance abuse Funding Cameras are installed in cars now and are working wonderfully.

Jason Boyer is giving up some of his time for the Fire Department EMS, Steven Peters explained the device called: The Bundle of Care and Impedance Threshold Device and stated it has 33% more cardiac output than regular CPR.

Total \$28.551.90 – One (1) in Meriden EMS and one (1) in Oskaloosa, for both Jefferson County Fire EMS facilities and is better for the patient too.

EMS will be responsible for upkeep and resupply. Match of \$3.750.00 is what Rock Creek Fire Department is giving. Steven Peters asked if City of Meriden could match this donation.

Motion was made by Richard White and seconded by Megan Steel to put \$4,000 toward Zoll Auto Pulse and take out of General Fund. Motion passed 3-0.

Jefferson County Fire Department #9, Steven Peters, will send an invoice to City of Meriden. .
