MAINTENANCE DEPARTMENT

Mayor Dana Boyer, spoke for Matt Williams, Maintenance Department, and relayed he would like to have blinking stop lights at the intersection of Main Street and Miller Street. The cost would be approximately \$3,400.

MAINTENANCE DEPARTMENT - CONT'D

Motion made by Floyd Cozadd, seconded by Brian Smith, to approve Ordinance #2202-01 to change yield signs to stop signs at Railroad Street, Water Street and Huffman Street running into Owen Street. Motion passed 4-0.

Matt Williams, Maintenance Department, sent out bids on the sidewalk project, east side of Owen from Wyandotte to Palmer, East side of Dawson from Wyandotte to Huffman, East side of Palmberg from Wyandotte to Palmer and sidewalk on south side of Wyandotte from Palmer to the end of the sidewalk improvement. CFS Engineering Bid on Sidewalk was \$19,500, and Mammoth bid was \$20,610. Tabled until February meeting.

ATTORNEY TIME

Lee Hendricks, City Attorney, stated that when the Jeff West Ball Association members attended the meeting a few months ago, the council informed them that the City had not had any conversations with Mammoth regarding status of the future of Lacey Ball Field. Since Mammoth appeared at this meeting, specifically discussed options in the future with Lacey Ball Field and stated they were open to discussions, Lee Hendricks felt it was important to contact the Jeff West Ball Association and inform them of the contact. Lee offered to contact the Board President, Tiffany McCall and inform her of the discussion and see if he can find any common ground between the two (2) Parties. The council agreed to have Lee contact Tiffany on the council's behalf.

Motion made by BJ Whiteman, seconded by Floyd Cozadd, to give Jerri Lederer a 4% COLA increase and everyone else a 2% COLA increase for 2022. Motion passed 4-0.
